



LIMITED WARRANTY FOR VEHICLE CONVERSION: MOBILE GROOMING VAN

1. Overview

This Limited Warranty ("Warranty") applies exclusively to the vehicle modifications and equipment installed by Pursuit Vehicle Innovations as part of the professional conversion of a standard cargo van into a mobile grooming unit.

This Warranty is provided in addition to, and does not replace, the manufacturer's warranty of the base vehicle.

Modifications covered under this Warranty include:

- Structural fabrication and modifications
- Plumbing
- Electrical integration
- Equipment installation completed as part of the dog grooming conversion

2. Term of Warranty

Pursuit Vehicle Innovations warrants the craftsmanship and materials used in the vehicle conversion for a period of (5) years or 60,000 miles, whichever occurs first, from the date the converted van is delivered to the end user.

This Warranty covers only components and systems directly modified or installed by Pursuit Vehicle Innovations and does not apply to any original equipment provided by the base vehicle manufacturer.

3. Scope of Coverage

Structural Fabrication

- Bulkheads and walls
- Sub floor and flooring
- Cabinetry
- Specialized equipment mounts, brackets, and fixtures

Plumbing

- Installation of water heater, freshwater tank, graywater tank, and inlet water fill adapter

Electrical

- Wiring and breaker box connections
- Circuits and distribution panels related to the conversion



3. Scope of Coverage

Ventilation Integration

- Installation of ventilation systems

Workmanship

- Installation of modified structures such as walls, floors, doors, and cabinetry
- Installation of all components and equipment associated with the conversion

Warranty services include:

- Repair or replacement of defective workmanship or materials installed by Pursuit Vehicle Innovations
- Labor costs associated with approved warranty repairs performed at an authorized service location

4. Exclusions

- Normal wear and tear
- Damage due to misuse, neglect, accidents, or unauthorized modifications
- Cosmetic imperfections not affecting functionality
- Failures caused by environmental exposure, including:
 - Corrosion
 - Water intrusion (unless caused by faulty installation)
- Consumable items (hoses, filters, bulbs, fuses, etc.)
- Any equipment covered under its own manufacturer's warranty (see Section 6)

This Warranty will be void if

- Repairs are performed by unauthorized personnel
- Original installation or components are altered without prior written approval from Pursuit Vehicle Innovations

5. Relationship to Manufacturers Warranty

This Limited Warranty is separate from and does not supersede the original manufacturer's warranty on the base van. Any repairs or claims related to the base vehicle, including the engine, drivetrain, chassis, or body must be handled directly with the original vehicle manufacturer or authorized dealer.
